Dear Ms. Merdegia:

Based on the recommendation of the Commission on Human Rights Bids and Awards Committee for Goods and Services (BAC-GS), we are pleased to inform you that the Procurement of the Supply and Delivery of One (1) Unit Brand New Passenger Van is hereby awarded to your company as the bidder having been declared as the Single Calculated and Responsive Bidder (SCRB) with a total contract amount of **Two Million Two Hundred Thousand Pesos (PhP2,200,000.00), inclusive of all existing and applicable government taxes and charges.**

a) Cash or cashier's/manager's check issued by a Universal or Commercial Bank.	Five Percent (5%)=PhP110,000.00
b) Bank draft/guarantee or irrevocable letter of credit issued by a Universal Bank: Provided, however, That it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank.	
c) Surety bond callable upon demand issued by a	

surety or insurance company duly certified by the Insurance Commission as authorized to issue such security

Thirty percent (30%)=PhP660,000.00

1. Original copy of Official Receipt (OR) of the Performance Bond
2. Original Cover Page and Acknowledgement
3. Original Indemnity Agreement

5. Photocopy of Certification of No Pending Informal Complaint from Insurance Commission
