RESOLUTION NO. 04-042 Series of 2021

**RECOMMENDING THE SHORTLISTED CONSULTANTS FOR THE
PROCUREMENT OF CONSULTING SERVICES FOR THE MENTAL
AND HUMAN RIGHTS SURVEY FOR CY 2021**

WHEREAS, the Commission on Human Rights (CHR), through its HR Policy and Advisory Office, intends to procure Consulting Services for the Mental and Human Rights Survey for CY 2021 with an Approved Budget for the Contract (ABC) of Two Million Four Hundred Thousand Pesos (PhP2,400,000.00);

WHEREAS, said procurement project shall be sourced from the 2021 GAA of CHR and is pursuant to the CHR Annual Procurement Plan (APP) for CY 2021;

WHEREAS, the Bids and Awards Committee for Consulting Services and Infrastructure Projects (BAC-CSIP) determined the mode of procurement as Competitive Bidding under Section 10 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, the BAC Secretariat, through the authority of the BAC-CSIP, published the Request for Expression of Interest (RFEI), together with the checklist of requirements, Terms of Reference and Bidding Documents through PhilGEPS with Reference No.7639695 on April 23, 2021, and, simultaneously, in the CHR website and conspicuous places within CHR;

WHEREAS, two prospective bidders, namely, **Asian Social Project Services Inc.** and **Social Weather Stations** expressed their interest to join the bidding and submitted bid proposals before the deadline for the submission of eligibility documents;

WHEREAS, on April 29, 2021, the BAC-CSIP opened the bid proposals and evaluated them using the "non-discretionary pass/fail criteria"; subsequently, the BAC-CSIP determined that the bid proposals "**passed**" the evaluation;

WHEREAS, the BAC-CSIP instructed the BAC Technical Working Group (TWG) to evaluate the bid proposals of the two prospective bidders; subsequently, on May 5, 2021 the BAC-TWG submitted the result of its bid evaluation through the BAC Secretariat;

WHEREAS, on May 6, 2021, during the BAC-CSIP meeting, the BAC-TWG discussed its evaluation finding that the two prospective bidders complied with the submission of all the required documents and recommended that **Asian Social Project Services Inc.** and **Social Weather Stations** be shortlisted;

WHEREAS, the **BAC-CSIP**, in considering the result of the bid evaluation of BAC-TWG declared **Asian Social Project Services Inc.** and **Social Weather Stations** as shortlisted bidders of the subject procurement project and may join the bidding;

NOW, THEREFORE, having considered the foregoing circumstances, the BAC-CSIP unanimously resolves to recommend that the shortlisted bidders **Asian Social Project Services**

Inc. and Social Weather Stations be considered Eligible for the procurement of Consulting Services for the Mental Health and Human Rights Survey for CY 2021;

RESOLVED FURTHER, that, upon approval by the Head of the Procuring Entity (HOPE) of this shortlisting, the pre-bid conference be scheduled on May 14, 2021 at 1:30 in the afternoon via the online platform.

RESOLVE FINALLY to post this Resolution at the CHR Website, PhilGEPS and conspicuous places within the premises of CHR.
