RESOLUTION NO. 11-238 Series of 2020

**RECOMMENDING FAILURE OF BIDDING FOR THE PROCUREMENT
OF SUPPLY AND DELIVERY OF LAPTOP**

WHEREAS, the Commission on Human Rights (CHR), through the Office of the HR Centers Management Office-Center for Crisis, Conflict and Humanitarian Protection (HRCMO-CCCHP), intends to procure supply and delivery of laptop with an Approved Budget for the Contract (ABC) of Ninety-nine Thousand Nine Hundred Sixty Pesos (PhP99,960.00);

WHEREAS, said procurement project shall be sourced from the 2020 CHR-UNHCR fund of the HRCMO-CCCHP pursuant to the CHR Annual Procurement Plan (APP) for CY 2020;

WHEREAS, the Bids and Awards Committee for Goods and Services (BAC-GS) determined the mode of procurement as Negotiated Procurement through Small Value Procurement under Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, the BAC-GS, through the BAC Secretariat, complied with the requirement of advertisement and posting of procurement opportunities as stated in annex "H" of the updated 2016 revised IRR of RA 9184 entitled "Consolidated Guidelines for the Alternative Methods of Procurement" and posted the Request for Quotation (RFQ) in the PhilGEPS website and CHR website. The same was also simultaneously sent out to at least three (3) suppliers of known qualifications;

WHEREAS, during the opening and evaluation of bids, the BAC-GS found that only Joneco Tech. Marketing Corp. submitted bid proposal as follows:

WHEREAS, in view of the foregoing, the BAC-GS recommends for a failure of bidding pursuant to Section 35.1 (c) of the Revised IRR of RA 9184 which provides that "*The BAC shall declare the bidding a failure when – "All bids fail to comply with all the bid requirements x x x"* of the revised IRR of RA 9184. Further, the BAC-GS recommends the re-bidding of the subject procurement project;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC-GS hereby resolves as it hereby resolved to **DECLARE A FAILURE OF BIDDING** pursuant to Section 35.1 (c) of the Revised Implementing Rules and Regulations (IRR) of Republic Act No.9184 which provides that *"The BAC shall declare the bidding a failure when - All bids fail to comply with all the bid requirements x x x."* Further, the BAC-GS hereby resolves as it hereby resolved to **RECOMMEND THE RE-BIDDING** of the subject procurement project pursuant to Section 35.3 of the Revised IRR of RA 9184.
